

Scholarship Rules and Regulations for College Applicants

Essay Requirements

Essays will be judged on whether the student is able to argue for and justify his or her ideas on renewable energy. Judges will look for writing that is clear, articulate and logically organized. Essay must be 1,500 words in length. Spelling errors and/or written corrections found by the judges on the essay will count against the final score and should be omitted before submission.

Applicant Eligibility

Applicant must be a U.S. Citizen or Permanent Legal Resident of the United States. Employees of Semper Solaris, its parents, affiliates and subsidiaries, participating advertising and promotion agencies, and members of said employees' immediate family and those living in the same household of employees are not eligible.

Applicant must be a current freshman, sophomore, junior, senior, graduate student, or attending a military academy at the time of submission. Applicant must have a cumulative college grade point average of at least 3.0 on a 4-point scale, and be enrolled full-time at an accredited college or university between January 1, 2022 and December 31, 2022.

Applicants attending military academies are eligible for this scholarship. See College/University Approval section for more details.

Distribution of Payments

The winning first place recipient will receive a one-time, \$3000 scholarship. The winning second place recipient will receive a one time, \$1750 scholarship. The scholarship is to be applied to qualified expenses, including graduate and undergraduate tuition, fees, books, and on-campus room and board for the 2022 academic year. Funds are provided directly by Semper Solaris. Payments are issued by Semper Solaris, made payable to the student to the last address designated by the student. Payments are sent after Semper Solaris has received

proof of GPA, enrollment from the student's accredited college or university, and has submitted a completed W-9 form.

Winner Selection and Announcements

The winner will be announced a week after the deadline, November 30th, 2022. Each entry will be judged on creativity, intricacy, and relevance to the prompt, as well as how they promoted their post. All entries must be shared with scholarships@sempersolaris.com.

College/University Approval

The institution must be accredited and listed on the official website of the [U.S. Department of Education](#). Applicants attending military academies are eligible for this scholarship. All school transfers are subject to accreditation approval.

Responsibilities of Recipients

The recipient must be actively enrolled at the time of submission as a full-time freshman, sophomore, junior, senior, or graduate student in Spring 2022 - Fall 2022 and for the entire academic year without interruption, barring illness, emergency, or military service. The recipient must send proof of GPA and enrollment from the student's accredited college or university within 30 days of being contacted as a winner (PLEASE NOTE THAT ACCEPTANCE LETTERS ARE NOT CONSIDERED AS PROOF OF ENROLLMENT AND WILL AUTOMATICALLY DISQUALIFY YOUR SUBMISSION). It is the recipient's responsibility to verify receipt of funds and notify Semper Solaris should the award check not arrive on or after 30 days from the issue date.

Permissions

Semper Solaris reserves the right to alter or discontinue this program at any time without notice.

Contest Terms and Conditions

The rules of the competition and the prize for each winner are as follows:

2. Employees of Semper Solaris, its parents, affiliates and subsidiaries, participating advertising and promotion agencies, and members of employees' immediate family and those living in the same household of employees are not eligible.
3. Applicants must be at least 18 years old in order to participate.
4. Only U.S. Citizens and Permanent Legal Resident of the United States are eligible to participate.

9. Only one entry is allowed per applicant per quarter.
10. Odds of winning are based on the total number of entrants. Only 2 winners will be selected from the entire pool of eligible entries.
11. Winners will be chosen by an independent adjudicator or panel of judges appointed by Semper Solaris.
12. The winner will be notified by email and/or letter within 35 days of the closing date. If the winner cannot be contacted or does not claim the prize within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.
13. Semper Solaris will notify the winner when and where the prize can be collected.
14. The first place winner will receive a one-time, \$3,000 scholarship to be applied to qualified expenses. The second place winner will receive a one-time, \$1,750 scholarship to be applied to qualified expenses.

15. No cash alternative to the prizes will be offered. The prizes are not transferable. Prizes are subject to availability and Semper Solaris reserves the right to substitute any prize with another of equivalent value without giving notice.
